

A study on effect of combined yoga and naturopathy on triglycerides among stressed people

Abstract

The purpose of the present study was to investigate the effect of combined yoga and naturopathy on triglycerides among stressed people. To achieve the purpose of the study thirty stressed people were selected from Karaikudi, Tamil Nadu, India during the year 2019. The subject's age ranges from 25 to 35 years. The selected students were divided into two equal groups consists of 15 subjects each namely experimental group and control group. The experimental group underwent a combined yoga and naturopathy programme for six weeks. The control group was not taking part in any training during the course of the study. Triglyceride was taken as criterion variable in this study. The selected subjects were tested on Triglycerides was measured through Triglycerides analyzer method (blood test in lab). Pre-test was taken before the training period and post-test was measured immediately after the six week training period. Statistical technique 't' ratio was used to analyse the means of the pre-test and post test data of experimental group and control group. The results revealed that there was a significant difference found on the criterion variable. The difference is found due to combined yoga and naturopathy given to the experimental group on Triglycerides when compared to control group.

Research methodology

Selection of subjects

The purpose of the study was to find out the effect of combined yoga and naturopathy on triglycerides among stressed people. To achieve this purpose of the study, thirty stressed people were selected as subjects at random. The age of the subjects were ranged from 25 to 35 years.

Experimental design and implementation

The selected subjects were divided into two equal groups of fifteen subjects each, such as a combined yoga and naturopathy group (Experimental Group) and control group. The experimental group underwent Yogic training for six days per week for six weeks. Control group, which they did not undergo any special training programme apart from their regular physical activities as per their curriculum. The following bio chemical variable namely Triglycerides was selected as criterion variable. All the subjects of two groups were tested on selected criterion variable

Triglycerides was measured through Triglycerides analyzer method(blood test in lab) at prior to and immediately after the training programme.

Statistical technique

The ‘t’ test was used to analysis the significant differences, if any, difference between the groups respectively.

Level of significance

The Table-I shows that the mean values of pre-test and post-test of the control group on Triglycerides were 152.6 and 152.93 respectively. The obtained ‘t’ ratio was 1.32, since the obtained ‘t’ ratio was less than the required table value of 2.14 for the significant at 0.05 level with 14 degrees of freedom it was found to be statistically insignificant. The mean values of pre-test and post-test of the experimental group on Triglycerides were 152.46 and 149.26 respectively. The obtained ‘t’ ratio was 16.00* since the obtained ‘t’ ratio was greater than the required table value of 2.14 for significance at 0.05 level with 14 degrees of freedom it was found to be statistically significant. The result of the study showed that there was a significant difference between control group and experimental group in Triglycerides. It may be concluded from the result of the study that experimental group improved in Triglycerides due to six weeks of combined yoga and naturopathy.

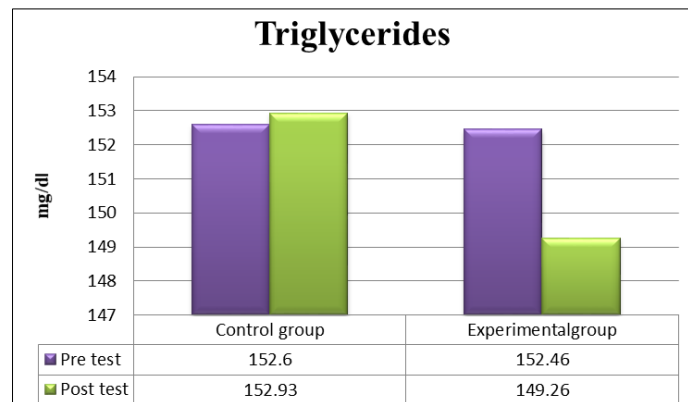


Fig 1: Bar Diagram Showing the Pre and Post Mean Values of Experimental and Control Group on Triglycerides

Discussions on findings

The result of the study indicates that the experimental group, namely combined yoga and naturopathy group had significantly improved the selected dependent variable, namely Triglycerides, when compared to the control group. It is also found that the improvement caused by combined yoga and naturopathy when compared to the control group.

The 0.05 level of confidence was fixed to test the level of significance which was considered as an appropriate.

Analysis of the data

The significance of the difference among the means of the experimental group was found out by pre-test. The data were analysed and dependent ‘t’ test was used with 0.05 levels as confidence.

Conclusion

On the basis of the results obtained the following conclusions are drawn

1. There was a significant difference between experimental and control group on Triglycerides after the training period.
2. There was a significant improvement in Triglycerides. However the improvement was in favor of experimental group due to six weeks of combined yoga and naturopathy.
